Special Relaxation of Statute for Admission to 3" & 5" Semester Students of FYUGP as per NEP-2020 for the year 2024-25.

Sir/Madam,

This is in reference to the several representation on the subject cited above from students as well as of the college principals received by the office of the Dean Academic Affairs. The matter was placed in the meeting held on 1" of July, 2024 and in the interest of careers of the students, the following was reserved to be communicated to the principal of the colleges:

As the result of NEP sem 2nd regular/private examination held last month is needed for making private students to earn their eligibility, it is intimated that admission to 5th semester, for such candidates shall be opened again, after declaration of result.

In the cases where students of NEP $1^{\mu}/3^{\mu}$ semester session (2023-24) are declared as N.E. on account of deficiency of shortage /failure in their internal assessment. The colleges are allowed to conduct the classes/re-exam. For such students and submit their awards etc. before 20th July, 2024. This shall be considered for admission when opened for (i) above.

The colleges are required to submit the internal assessment awards of the students of 2nd \/4" semester (NEP) 2023-24, who have been allowed to appear in semester end examination but their internal assessment is submitted as shortage/failure only. This shall be important to determine the eligibility for admission in 3'5 /5" semester (NEP) for the session 2024-25.

This shall be issued as a special case for the admission to academic session 2024-25.
